Project Description

On December 9, 2025, the City of Dublin Planning Commission approved the Sunflower Hill at Grace Pointe project for the construction of a three-story multi-family apartment building with 59 affordable units for people with intellectual and developmental disabilities and one manager's unit. The development includes a community room, makers space, fitness room, and amenitized central courtyard. Requested approvals include a Site Development Review Permit.

In compliance with the California Environmental Quality Act (CEQA), on November 15, 2022, the City Council certified the Final EIR for the SCS Dublin Project, which included up to 550 market rate residential units, up to 100 affordable units, up to 265,000 square feet of retail commercial development and related infrastructure and landscape improvements. Upon approval of the SCS Dublin Project, the City Council adopted a Mitigation Monitoring and Reporting Program and a Statement of Overriding Considerations (Resolution No. 135-22). Pursuant to CEQA Guidelines Section 15162, The Sunflower Hill at Grace Pointe project impacts

are covered by the SCS Dublin EIR and no further environmental review is required for this project.
